**ACLEDA Bank Plc.** ("ACLEDA Bank"), the first commercial Bank in Cambodia listed its shares on the Cambodia Securities Exchange ("CSX"), would like to notify all stakeholders that ACLEDA Bank has been officially approved by the National Bank of Cambodia and Ministry of Commerce for the following amendment to its MAOA:

## 1. Change in Ownership Structure:

**Shareholders Legalized from ASA, Plc.** transferred **64,961,218** shares equal to **14.9969%** of the total shares of ACLEDA Bank to **Public Shareholders** in accordance with shares trading on the CSX in 2022. At the end of February 2023, **ACLEDA Financial Trust** ("AFT") purchased **6,756,273** shares equal to **1.5598%** of the total shares of ACLEDA Bank through the CSX; therefore, shares of AFT increased to 118,248,992 shares.
