Amendment to the Memorandum and Articles of Association (MAOA)

ACLEDA Bank Plc. (ABC) is the first commercial bank in Cambodia listed its shares on the Cambodia Securities Exchange (CSX), would like to notify investors and the public that ABC has been officially approved by the National Bank of Cambodia and the Ministry of Commerce for the following amendment to its MAOA:

- 1. Change of logo
- 2. Increase the registered capital sourcing from the initial public offering (IPO) of USD 4,344,865 so total registered capital increased to USD 433,163,019 as below:
